- 1. Formulate legal questions
 - a. What is duty to account holder?
 - b. What is required to release account info?
 - c. Who is responsible to determine bank policy?
 - d. Etc.
- 2. Categorize Research Questions:
 - a. Federal/State
 - b. Procedural/substantive
 - i. Substantive Rights, duties and obligations that exist between individuals and institutions.
 - ii. Procedural Governs way the system works. F. R. Civ. P.
 - c. Break down into words and phrases to use in caselaw searches
- 3. Background Resources:

 - b. Zimmerman's Research Guide internet
